

Instructions:

Each individual participant must fill out the following application completely in order to participate on a mission trip with Passion Missions. Failure to complete this four page application in its entirety will result in the individual not being able to participate on the mission trip. No refunds will be given.

Personal Information: Please fill out this section completely. If traveling internationally you will need to include your passport # on this application. In the event that your passport would be lost or stolen while in another country, we would have documentation needed to speed up the process of getting it replaced. No personal information will be released without prior consent.

Medical History: Please be as specific as possible. This information may not be important the majority of the time, but in an emergency situation, these answers could save your life!

Emergency Contact: Please provide information of a person that can be contacted in case of an emergency on the trip. This can be a parent, a spouse, a friend or another relative.

Questions: Passion Missions desires to partner and connect the Body the Christ together. These questions allow our staff to get to know you, your background and where you are at before your trip. They also allow us to make decisions in regards to ministry opportunities that best fit your team and the individuals that participate on the team.

Covenant: It is important to be a team player while serving on the mission field. A covenant states that you agree and are willing to participate with others in working together. Be sure to check each box stating that you agree to follow each one and then sign the application at the bottom.

Consent: This is a waiver of liability. This part of the form must be filled out voluntarily and signed by the participant or if the participant is a minor, the parent or legal guardian must sign it as well. The form is a legally binding document and you have the right to consult an attorney before signing.

Medical Release: This form gives permission for you to be treated medically should you be unable to give your own consent or for a minor if the parent is not present. This form is a protection for you in case of an emergency.

The application and forms that this ministry requires is not because we love paperwork, but we must have these forms because of legal reasons to protect participants and be responsible for the lives God has entrusted to us for a short time.

As you begin to make the initial preparations for your mission trip, by filling out this application, I challenge you to change your mindset if you think that your mission trip is just around the corner; it has already started!

Consent Form

1. I hereby release and agree to hold harmless Passion Missions, its Staff, Mission Trip Leaders and those made known to me to be in authority during my Mission Trip from any and all legal liability as it relates to this Mission Trip. I further agree to waive any interest, legal right or claim I may have against Passion Missions, its Staff, Mission Trip Leaders and those made known to me to be in authority during my Mission Trip.
2. I hereby acknowledge that I am fully aware that by serving on this Mission Trip I am subjecting myself to hazards and risks to both my person and property. Furthermore I agree to assume all risk to both my person and property, and to hold harmless and free from any legal claim Passion Missions, its Staff, Mission Trip Leaders and those made known to me to be in authority during my Mission Trip should injury or damage occur to my person, my property or both. I acknowledge that the above-referenced risks include, but are not limited to, injury or death by accident, war, terrorist acts, weather conditions, inadequate medical services and supplies, criminal activity, random acts of violence, hazardous traffic, poorly constructed roads, sickness and disease.
3. I hereby acknowledge that it is my responsibility to provide myself with any insurance coverage that I may feel necessary with regard to my Mission Trip. This insurance may include, but is not limited to, coverage for medical treatment, disability, hospitalization, death, lost baggage, and lost or stolen property. I further agree to hold harmless Passion Missions, its Staff, Mission Trip Leaders and those made known to me to be in authority during my Mission Trip from any responsibility to provide insurance for my protection or insurance wherein I am the named insured.
4. I grant permission to Passion Missions and its agents or employees, to use photographs taken of me on mission trips for use in publications such as brochures, newsletters, magazines, and to use the photographs on display boards, and to use such photographs in electronic versions of the same publications or on Passion Missions web sites or other electronic form or media, and to offer them for use or distribution in other publications, electronic or otherwise, without notifying me. No photographs will be used for commercial gain and no personal information will be released unless prior written permission is given to Passion Missions.
5. I attest and certify that I have no medical conditions that would prevent me from performing the duties pertaining to a mission trip with Passion Missions

I agree to abide by all lawful rules, regulations and guidelines as set forth by Passion Missions and to abide by all decisions made by its Staff, Mission Trip Leaders and those made known to me to be in authority during my Mission Trip.
